1. For and on behalf of Governor of Jammu and Kashmir State, the Chief Town Planner, Town Planning Organisation, Jammu invites **Expression of Interest (EOI)** from eligible *Consultancy Firms/Schools of Planning and Architecture/Urban Planning Research Institutes of repute* for providing consultancy services for the preparation of **G.I.S based Master Plan for Ramnagar Town, District Udhampur, J&K State.**
2. The scope of the Consultancy would be the preparation of the Master Plan for Ramnagar Town as per Jammu and Kashmir Development Act 1970:
 - I. Carry out all field surveys and data collection necessary for the preparation of Master Plan
 - II. Procure the satellite imageries, digital elevation models and other necessary data needed for GIS based Master Plan
 - III. Submit Draft Master Plan
 - IV. Finalize the Master Plan on the basis of technical inputs from the Government/ Chief Town Planner-TPO-Jammu/citizen participation.
3. TPO invites eligible Consultants to express their interest in providing the Consultancy Services for the aforesaid assignment.
4. Interested consultants must provide the following information indicating that they are qualified to perform the required services in the Format (annexure A)
 - I. Technical Competence
 - II. Geographical Experience
 - III. Project References
 - IV. Availability of Skilled staff in planning, urban design, transport planning, environment planning, housing
 - V. Audited balance sheets of last three financial years
 - VI. Certificate of incorporation
5. The criteria for short listing shall be as follows:
 - (I) The firm should be in consulting business at least for the last 10 years (in case of JV all the members shall satisfy the requirement).
 - (II) The firm shall be financially sound with an annual average turnover of more than INR 1,00,00,000 during the previous three financial years (in case of JV, lead partner shall satisfy at least 50% of the requirement and all Joint Venture partners shall satisfy at least 25% of the requirement and jointly they shall satisfy 100% of the requirement).
 - (III) The firms should have a track record of successfully completing at least two similar assignments during the previous ten years

- (IV) Availability of skills among key staff in the disciplines of urban planning, urban design, transport planning, environmental planning, Civil Engineering and Architecture
(Note: I and II will not apply to Schools of Planning and Architecture/Urban Planning Research Institutes of repute)
6. The consultant may associate with other firms to enhance their qualification. (The "association" may take the form of a joint venture (with joint and several liability) or of a sub-consultancy), and this should be stated clearly in their submission.
 7. A consultant will be finally selected in accordance with Quality and Cost Based Selection (QCBS) procedures.
